**Q:** What is my system identifier and where do I find it?

**A:** Your system identifier is your SEDAR profile number. You can find it by going to [sedar.com](http://sedar.com) and going to your issuer profile. The number at the end of the URL will be your profile number.

**Q:** What is my Subscriber Number?

**A:** Leave this field blank as it only applies to self-filers and/or filing agents.

**Q:** What does Active Relationship refer to?

**A:** This indicates that you are currently a SEDAR filer and must be answered "Yes" to be onboarded to SEDAR+.

**Q:** What does Effective From Date refer to?

**A:** This is a required field and it refers to the company name. If the company has changed names at any point, it is the effective date of the current name. If the company has not changed names, then it is the date of incorporation.

**Q:** What is a Legal Entity Identifier (LEI)?

**A:** The LEI is a 20 digit alphanumeric code used across markets and jurisdictions to uniquely identify a legally distinct entity that engages in a financial transaction. This field can be left blank if the company does not have an LEI. If you are not sure if you have one, please check [here](#).

**Q:** Exchangeable Security or Credit Support?

**A:** Leave this field blank if neither applies to your company.

**Q:** Do I have to include a Closing Date of Qualifying Transaction?

**A:** Leave this field blank unless you are a Capital Pool Company. If you are a CPC, this date must be included.

**Q:** What is an NAICS Code and do I have to include this?

**A:** This is a required field. The NAICS is a 6 digit code used to classify the industry the company belongs to. You can use this [website](#) to search for the appropriate code for your company.

**Q:** Is the ISIN required?

**A:** If your company has an ISIN, it must be provided. You can search for your ISIN [here](#).
